- This award is specifically focused on leadership. Leadership is not only demonstrated by taking on a particular position, role, or
 title. A leader is someone who 'makes things happen'. Leaders set a goal or a vision, and bring others together to work towards
 getting there. Leaders are not only people who make big changes, but also the people who make sure the little things keep
 happening consistently even in the face of challenges.

DRAFT CITATION

- The citation should detail some of the reasons for the award and the way the person has contributed to Australian Red Cross.
- As only Australian Red Cross service is relevant, do not include other activities undertaken by this person.
- Avoid references to "I" (e.g. I have seen or I believe), the citation should be written in the 3rd person (e.g. Barbara has assisted with the ...). Do not include phrases such as "I recommend he be awarded..." or similar.
